REGIONAL LAW162/1998 SARDINIAN REGION: FINANCING FOR PERSONALIZED PLANS FOR PEOPLE WITH SEVERE DISABILITIES

The Sardinian Region, from 19 years, provides funding to municipalities for the implementation of personalized plans that provide social and assistance interventions for children, young people, adults and older people with severe disabilities, aimed at developing full potential, support for family care and full integration In the family, in school and in society.

REGIONAL LAW162/1998 SARDINIAN REGION FINANCING FOR PERSONALIZED PLANS FOR PEOPLE WITH SEVERE DISABILITIES

Custom plans may include, in particular, the following services:

- educational service (not foreseen for the sixty-six);

- personal and / or home assistance (personal assistance means the person's assistance, while home care is related to the care of the same person's living environment);

- reception at authorized day centers, limited to the payment of the social security fee;

- stay at social and sociological facilities and authorized health care residences for not more than 30 days within a year and limited to the payment of the social security fee;

- sports and / or social activities (not foreseen for the sixty-six).

REGIONAL LAW162/1998 SARDINIAN REGION FINANCING FOR PERSONALIZED PLANS FOR PEOPLE WITH SEVERE DISABILITIES

The municipality may manage the interventions in direct form by providing them with the service to the beneficiaries, or indirectly, provided that the beneficiary or the person entrusted to enter into the contract with the service providers

REGIONAL LAW162/1998 SARDINIAN REGION FINANCING FOR PERSONALIZED PLANS FOR PEOPLE WITH SEVERE DISABILITIES

The Municipality prepares the plan in collaboration with the family of the person concerned and, if necessary, with the health services, on the basis of appropriate assessment sheets:

- the "<u>Health Card</u>" on the assessment of the situation of the person with disabilities (senses and language, daily activities, relationship life).

- the "<u>Social Card</u>", which contains the additional information necessary for the preparation of the personal plan (age, benefits, family cares, particular discomfort situations ...). ").

Depending on the information in the two tabs, the City will assign to the Custom Plan a score to determine the maximum amount of eligible funding. Subsequently, the body will determine the amount that may actually be allocated on the basis of income

PLUS (UNITARY LOCAL PLAN OF PERSONAL SERVICES): WHAT IS?

The Unitary local Plan for Personal Services (P.L.U.S.) is the programming tool provided by a regional law on personal service reorganization. It is a plan of interventions and actions that has to be elaborated and realized with the contribution of a number of actors called to engage in a common path and that, for this purpose, will have to find shared tools, methods and languages. Through this tool, the various actors that build the network of services to the people in the district (Hospitals: Municipalities, Provinces, Professional Actors, Social and Solidalists, etc) together set goals and priorities, plan and place Integrated social, health and social interventions, also with the direct contribution of citizens

PLUS (UNITARY LOCAL PLAN OF PERSONAL SERVICES) WHAT IS?

The P.L.U.S., albeit in line with national and regional programming, will have to be implemented locally, taking into account the specificities of the individual spatial areas involved and will represent the strategic planning tool for social-health integration for:

• Promote sharing of responsibility and resources;

•Identify the needs, resources, and development potential of territory;

• Implement Community Social Development Programs;

• Defines responses to the healthand social needs of the Population of the territory;

• Implement essential service levels.

PLUS (UNITARY LOCAL PLAN OF PERSONAL SERVICES) WHAT IS?

The Plan defines actions over the three-year period. Three-year programming is needed because time and constancy is needed to achieve high-quality health results. An annual economic-financial update can be required and, in the same implementation period, the re-modification of content will be permitted, if deemed necessary.

PLUS (UNITARY LOCAL PLAN OF PERSONAL SERVICES) WHERE IS?

Nughedu Santa Vittoria is one of the municipalities that is part of a PLUS: it is called the Healtcare district of Bosa – Ghilarza. It gives several services to the population of many municipalities in the west central part of Sardinia, not only for healtcare but even social services (we will focus on the first).

The Plus has a PUA (Unique point of access): it is the way all the citizens can access healtcare and choose the better service through:

Giving information and answers;
Giving the chance to every citizen to go in only one place for all the needs;
Helping communication between healt professionals and citizens.

CARE ASSISTANCE: This is a contribution of 3.000,00 € per year, given to the family of the disable person through the Municipality where he lives.

Coming home programme: Main objective of the programme is to facilitate the coming back to family of people embedded in social and / or healthcare facilities or to avoid hospitalization. Not only rising up of the life quality of the person with self-sufficiency compromised, but even a help to the family (even economic).

Personalized plan for people with severe disabilities:

The interventions are aimed at facilitating the stay of non-dependents in their home country, by activating or strengthening the integrated care and home care network through the diversification of typologies and intervention arrangements.

Personalized plan for people with severe disabilities, the services:

- personal assistance and / or home care
- reception at authorized day centers, limited to the payment of the social security fee;
- stay at authorized social and / or social housing structures, for no more than 30 days in one year and limited to the payment of the social security fee;
- ▶ sports and / or socialization activities (not foreseen for ultra-sixty-five);
- educational service (not foreseen for ultra-sixty-five).

Elimination of architectural barriers:

Through the City of Residence, the Region grants people with disabilities funds for the execution of works aimed at overcoming or abandoning architectural barriers in private buildings built before the entry into force of Law no. 13 of 9/01/1989.

Sussides for people with cancer:

The Region provides, through the municipalities, economic benefits to people suffering from malignant neoplasia, resident in Sardinia.

These allowances, determined on the basis of the income and the consistency of the family, consist of the reimbursement of travel and subsistence expenses incurred to undergo antitumor therapy at health facilities situated in a municipality of Sardinia other than that of residence. Interested parties must submit their application to the City of Residence. The right to subsidies begins on the day when treatment begins and is treated.

Economic contribution for people with mental disturb:

People with mental disorder can benefit from the benefits provided by the Region through the municipalities. The allowance consists of a monthly allowance, which is recognized as from the first day of the month following the submission of the application. The amount of the allowance is determined on the basis of the parameters set annually by the Advisory Board and the individual income.
